

#### Note:

- All dimensions specified herein are in meters
- Dimensions indicated shall have a tolerance of +5 mm, from the minimum.

#### Appearance:

- 1. Powdercoating thickness shall be 60 microns minimum.
- 2. Clean appearance, shall be made of a minimum of 1mm thk. steel.
- 3. Corners shall be brazed for smooth finish.
- 4. Shall be fully welded and built to last.
  - "Fully welded" shall mean welding running from top to bottom and left to right of all lap
