CLARIFICATION No. 1:

The requirement for the proposed technologies and brand of equipment must be included in the list of Gartner Magic Quadrant for Wired and Wireless LAN Access Infrastructure for 2019 is a consensus and decision recommendatory from the concerned IT groups of AMLCS that conducted thorough analysis of competing markets that provides an insight and serves as a guide in evaluating and selecting a technology and/or service provider/vendor that will maximize (take full advantage) for the security requirements, deployment of mission-critical applications as well as futureproofing requisites of the AMLCS.

Issue 5:

Section VII. Technical Specifications

The prospective bidder is requesting to consider technologies that were not able to support 4G and GPS.

CLARIFICATION No. 2:

Mobile access point device must be able to support 4G and GPS, considering that 4G has strong signal with good data speeds, while GPS is a prerequisite in obtaining a stable 4G signal relative to data throughput.
