CONTRACT AGREEMENT

THIS AGREEMENT made this 6th day of February 2023 between the ANTI-MONEY LAUNDERING COUNCIL of the Philippines, represented by its Executive Director, Matthew M.  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of **Seven Million Eighty Thousand Pesos** (PHP7,080,000.00) or such other sums as may be ascertained, the **Total Information Management Corporation** agrees to deliver and implement **One** (1) Lot Multi-Year Subscription of Sangfor Hyper Converged Infrastructure Maintenance in accordance with its Bid.
- 4. The **ANTI-MONEY LAUNDERING COUNCIL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






