- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. - 3. In consideration for the sum of *Two Hundred Thirty-Three Thousand Pesos* (PHP233,000.00) or such other sums as may be ascertained, the Panrama Technologies Enterprises agrees to deliver and implement One (1) Lot Multi-Year Maintenance and Support of Active Devices in accordance with its Bid.
