Contract Agreement for the Procurement of One (1) Lot Multi-Year Maintenance of CCTV and Door Access System

CONTRACT AGREEMENT

THIS AGREEMENT made this ______day Feb 0 2 2023 between the ANTI-MONEY LAUNDERING COUNCIL of the Philippines, represented by its Executive Director, Matthew M. David, with office address at Room 507, 5/F, EDPC Building, BSP Complex, Malate, Manila (hereinafter called "the Procuring Entity") of the one part and DGL Veracity Systems Corp., represented by its Authorized Representative, Mr. Ruel O. Rodolfo, with office address at 6 6th Ave, Cubao, Quezon City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, particularly One (1) Lot Multi-Year Maintenance of CCTV and Door Access System and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Three Hundred Ninety-Six Thousand Pesos (PHP396,000.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz*.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the

Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of *Three Hundred Ninety-Six Thousand Pesos* (PHP396,000.00) or such other sums as may be ascertained, the DGL Veracity Systems Corp. agrees to deliver and implement One (1) Lot Multi-Year Maintenance of CCTV and Door Access System in accordance with its Bid.
- 4. The **ANTI-MONEY LAUNDERING COUNCIL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
