CONTRACT AGREEMENT

THIS AGREEMENT made this 2day of 2023 between the ANTI-MONEY LAUNDERING COUNCIL of the Philippines, represented by its Executive Director, Matthew M.  - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract: and
 - iv. Supplemental or Bid Bulletins, if any:
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *Four Million Eight Hundred Twenty-Eight Thousand Three Hundred Pesos (PHP4,828,300.00)* or such other sums as may be ascertained, DBQuest, Inc. agrees to deliver and implement PR No. 23-007: One Lot Multi-Year Maintenance of Oracle Database Appliance in accordance with its Bid.
- 4. The **ANTI-MONEY LAUNDERING COUNCIL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
