Contract for the Procurement of Data Mining System Annual Maintenance

THIS AGREEMENT made on the 21th day of October 2023 between ANTI-MONEY LAUNDERING COUNCIL of the Philippines, represented by its Officer-in-Charge, Emmett Rodion O. Manantan, with office address at Room 507, 5/F, EDPC Building, BSP Complex, Malate, Manila (hereinafter called "the Procuring Entity") of the one part and INFOBAHN COMMUNICATIONS, INC. represented by its Authorized Representative, Maricris S. Edañol, with office address at 2F Fil-am Bldg. 923 Aurora Blvd. Cor. La Salle St., Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, particularly *Purchase Request No. 23-043*: Procurement of Data Mining System Annual Maintenance and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Eleven Million Eight Hundred Seventy-Five Thousand Pesos (Php11,875,000.00) (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and

Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of Eleven Million Eight Hundred Seventy-Five Thousand Pesos (Php11,875,000.00) or such other sums as may be ascertained, INFOBAHN COMMUNICATIONS INC agrees to Purchase Request No. 23-043: Procurement of Data Mining System Annual Maintenance in accordance with his/her/its Bid for the period 21 November 2023 to 20 November 2024.
- 4. The *Anti-Money Laundering Council* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


