Maintenance of 5KVA APC UPS (Purchase Request No. 23-025)

#### **BRIEF DESCRIPTION**

This project is for the procurement of preventive maintenance and support services for the 5KVA APC Uninterruptible Power Supply (UPS) of the AMLC.

The Approved Budget for the Contract (ABC) is Php177,715.00.

#### **INSTRUCTIONS TO SUPPLIERS**

#### **GENERAL CONDITIONS**

#### **Quotation Price:**

Supplier's quotation shall be inclusive of all costs, applicable tax, charges and other incidental expenses, including, but not limited to notarial expenses.

#### Quotation Validity Period:

Quotations shall be valid for 60 days from receipt by the BAC Secretariat.

Delivery Period/Completion Period/Contract Period:

Contract period shall be One year from 08 April 2023 to 07 April 2024.

#### Liquidated Damages:

- A delay by the Supplier in the full delivery of the goods/services shall render the Supplier liable for liquidated damages, which shall be deducted by the AMLC from each payment or total contract price in case of one-time payment.
- Liquidated damages shall be equal to one-tenth (1/10) of one percent (1%) of the total contract price for every day of delay.

#### Payment:

- Payments shall be made only upon the issuance of the Inspection and Acceptance Report (IAR)<sup>2</sup> by the Inspection and Acceptance Committee (IAC) of the submitted service report duly signed and certified by ITSS after every scheduled preventive maintenance.
- No payment shall be made for supplies and materials not yet delivered or services not yet rendered.
- The Supplier's request for payment shall be made in writing, accompanied by an invoice describing, as appropriate, the goods delivered and/or services performed, and by documents submitted pursuant, and upon fulfillment of other obligations stipulated in these Terms of Reference.
- Payments shall be made promptly by the AMLC within thirty (30) days from issuance of the IAR by the IAC.
- The currency in which payment is to be made shall be in Philippine Pesos.

#### Warranty:

The Supplier warrants it has, and, at all time during the term of the service, will
maintain the requisite personnel, competence, skill and resources necessary to
provide the required services under these Terms of Reference. The Supplier also
warrant that the services shall be performed in a workmanlike manner and in

compliance with all applicable laws and regulations. The Supplier further warrants the availability of service, service parts and maintenance services, including repair services and preventative maintenance, during the term of the service. Additionally, the Supplier warrants that the services rendered is fit for the use for which it was intended.

 The AMLC shall promptly notify the Supplier in writing of any claims arising under the warranty. Upon receipt of such notice, the Supplier shall, within 7 days and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the AMLC.
