

CONTRACT RENEWAL (RE: Internet Connectivity Subscription)

KNOW ALL MEN BY THESE PRESENTS:

This *Contract Renewal (Re: Internet Connectivity Subscription)*, entered and executed between:

The **ANTI-MONEY LAUNDERING COUNCIL**, a government instrumentality created under Republic Act No. 9160, also known as the Anti-Money Laundering Act of 2001, as amended, represented by its Executive Director, **ATTY. MATTHEW M. DAVID**, with office address at Room 507, EDPG Building, Bangko Sentral ng Pilipinas Complex, Roxas Boulevard, Manila, hereinafter, referred to as the "AMLC";

- and -

The **PLDT INC.** represented by its First Vice President and Sector Head of Enterprise Revenue Group I, **MR. VICTOR Y. TRIA**, with office address at Ramon Cojuangco Bldg., Makati Ave., Makati City referred to as the "Internet Service Provider";

(Each a "Party" and collectively the "Parties")

WITNESSETH:

WHEREAS, the Parties have an existing *Contract for the Procurement One Year Internet Subscription Services* with P.O. No. 2022-07-013 dated 20 July 2022 for the internet services in the following sites: Manila site – 200 Mbps, Quezon City site – 50 Mbps, Lease Line Connection between Manila and Quezon City – 100 Mbps;

WHEREAS, the said *One Year Internet Subscription Services* has expired on 31 August 2023;

WHEREAS, the contract with the Internet Service Provider was extended twice: first from 01 September 2023 to 30 November 2023, and second from 01 December 2023 to 29 February 2024. The second extension was terminated effective on 31 December 2024, upon the effectivity of the *Contract Renewal* from 01 January 2024 to 30 June 2024,

which was further extended for two months, from 01 July 2024 to 31 August 2024;

WHEREAS, access to internet services is essential, indispensable and necessary to the day-to-day operations of the AMLC to ensure continuous discharge of its mandate;

WHEREAS, the original contract was awarded in accordance with the provisions of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, and its 2016 Revised Implementing Rules and Regulations (IRR), and other relevant issuances.

WHEREAS, the AMLC has authorized the procurement of the project "Subscription of Internet Services" under Item No. 33 of the AMLC Annual Procurement Plan (APP) for FY 2024;

WHEREAS, the internet connectivity subscription is a regular and recurring service as defined under Section 3.1 of Government Procurement Policy Board Resolution No. 06-2022, dated 12 September 2022 entitled the Guidelines on Renewal of Regular and Recurring Services considering that it has repeatedly been procured by the AMLC at least in the last three (3) years.

NOW THEREFORE, for and in consideration of the foregoing premises, the Parties hereto agree and stipulate the following:

1. Renewal of Contract

1.1. The Parties agree to renew the contract of the *Internet Connectivity Subscription* under the same terms and conditions, as herein prescribed as follows:

- 1.1.1. Internet Connection Service for AMLC Manila up to 200Mbps;
- 1.1.2. Internet Connection Service for AMLC Quezon City up to 50Mbps;
- 1.1.3. Leased Line Connection between AMLC Manila and Quezon City up to 100Mbps; and
- 1.1.4. Inclusive of Static /29 Public IP Address.

1.2. The *Internet Subscription Services Contract with P.O. No. 2022-07-013 dated 20 July 2022* is made an integral part of this document.

2. Renewal Cost

Renewal of contract of the Internet Subscription costs shall be in the total amount not to exceed **Php250,216.00.00** for the whole duration of the contract. This amount has been established based on the understanding that it includes all costs, as well as any tax obligation that may be imposed on the Internet Service Provider.

The breakdown are as follows:

3. Duration, Termination and Amendment

- 3.1 This Renewal Contract shall be valid for a period of month (1) month, starting 01 September 2024 and ending on 30 September, renewable at the option of the AMLC, subject to the execution of another Contract.


