#### CONTRACT

This Contract for the One Lot Upgrade of Internet Subscription Services ("Contract") made this fifthe Day of July 2024 between ANTI-MONEY LAUNDERING COUNCIL of the Philippines, represented by its Executive Director, Matthew M.     - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of One Million Three Hundred Eighty-Seven Thousand Seven Pesos (Php1,387,007.00) or such other sums as may be ascertained, CONVERGE INFORMATION AND COMMUNICATIONS TECHNOLOGY SOLUTIONS, INC., agrees to One Lot Upgrade of Internet Subscription Services in accordance with his/her/its Bid.
- 4. The **ANTI-MONEY LAUNDERING COUNCIL** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.

## **DURATION, TERMS, and AMENDMENT**

In consideration of the payment to be made by the Procuring Entity to the Supplier, the Supplier hereby covenants to complete within sixty (60) calendar days from receipt of the Notice to Proceed (NTP) the supply, delivery, installation, configuration, and testing. The one-year (12-month) internet subscription will begin upon completion of all stages of project implementation and acceptance of the Inspection and Acceptance Committee. final acceptance of the project.

- 5. In consideration of the delivery of said goods and services, the Contract Price or such other sum as may become payable under this Contract, the Procuring Entity shall process the payment within thirty (30) days from the issuance of Certificate of Completion.
- 6. Any amendment to this Contract shall be made in writing and signed by the Procuring Entity and the Supplier.
