BRIEF DESCRIPTION

Subscription to a cloud-based name screening database for money laundering, terrorism financing, sanctions, politically exposed persons, including adverse media with nine (9) licenses.

The Approved Budget for the Contract (ABC) is PHP995,000.00, as indicated in the Purchase Request.

INSTRUCTIONS TO SUPPLIERS

Form of Quotation:

Suppliers¹ are required to submit its Quotation using the Prescribed Form (*See* Page 6) by the Anti-Money Laundering Council (AMLC). Non-compliance with the prescribed forms shall be a ground for automatic disqualification.

Documentary Requirements:

The following documentary requirements should be submitted at the time of the submission of the Supplier's Quotation:

- Mayor's/Business Permit (BIR Certificate of Registration for individual supplier)
- PhilGEPS Registration Number/Certificate
- Income/Business Tax Return
- Omnibus Sworn Statement and if applicable, Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative [Use AMLC Prescribed Form] (See Pages 8-11); or Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Supplier.

GENERAL CONDITIONS

¹ Or Service Providers (for procurement of services).

Quotation Price:

Supplier's quotation shall be inclusive of all costs, applicable taxes, fees and charges (i.e. remittance charges, service fees, etc.) as well as incidental expenses, including, but not limited to notarial expenses.

Supplier's quotation in foreign currency shall indicate and provide its equivalent in Philippine Peso, otherwise, the same shall be converted to the prevailing exchange rate at the time of the deadline for submission of quotation and for purposes of determining the lowest calculated quotation.

Quotation Validity Period:

Quotations shall be valid for sixty (60) calendar days from receipt by the BAC Secretariat.

Delivery Period/Completion Period/Contract Period:

Contract period shall be from 07 June 2024 to 6 June 2025. Date of Purchase Order Form, when earlier than 07 June 2024, shall not affect the contract period.

Liquidated Damages:

- A delay by the Supplier in the full delivery of the goods/services shall render the Supplier liable for liquidated damages, which shall deducted by the AMLC from each payment or total contract price in case of one-time payment.
- Liquidated damages shall be equal to one-tenth (1/10) of one percent (1%) of the total contract price for every day of delay.

Payment:

- Payments shall be made only upon the issuance of the Inspection and Acceptance Report (IAR)² by the IAC.
- No payment shall be made for supplies and materials not yet delivered or services not yet rendered.
- The Supplier's request for payment shall be made in writing, accompanied by an invoice describing, as appropriate, the goods delivered and/or services performed, and by documents submitted pursuant, and upon fulfillment of other obligations stipulated in these Terms of Reference.

² Certificate of Acceptance (for Consultancy Services).

- Payments shall be made promptly by the AMLC within thirty (30) days from issuance of the IAR by the IAC.
- The currency in which payment is to be made shall be in Philippine Peso. The supplier/provider may be paid the foreign currency equivalent of the amount of the contract to be computed based on the exchange rate prevailing on the date of the remittance. The difference thereof shall be for the account of the supplier/provider and the remittance charge/service fees shall be deducted from the contract price.

Warranty:

- The Supplier shall guarantee the faithful performance of its obligations under the contract in accordance with the Terms of Reference. The Supplier warrants it has, and, at all times during the term of the service, will maintain the requisite personnel, competence, skill and resources necessary to provide the required services under these Terms of Reference. The Supplier also warrant that the services shall be performed in a workmanlike manner and in compliance with all applicable laws and regulations. The Supplier further warrants the availability of service, service parts and maintenance services, including repair services and preventative maintenance, during the term of the service. Additionally, the Supplier warrants that the services rendered is fit for the use for which it was intended.
- The performance of the obligation and the warranty shall be covered by a warranty security³ in the form of retention money in an amount equivalent to five percent (5%) of the total contract price in case of one-time payment.
- The warranty security shall be denominated in Philippine Pesos and posted in favor of the AMLC, which shall be forfeited in the event it is established that the winning Supplier is in default in any of its obligations under the contract.
- The AMLC shall promptly notify the Supplier in writing of any claims arising under the warranty. Upon receipt of such notice, the Supplier shall, within 5 calendar days and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the AMLC. If the Supplier, having been notified, fails to remedy the defects within the period specified in the contract, the AMLC may proceed to call upon the warranty security, without prejudice to any other rights which it may have against the Supplier under these Terms of Reference and under the applicable law.
- The warranty security shall only be released after issuance by the Inspection and Acceptance Committee (IAC) of the Certificate of Final Acceptance (CFA).
- After the lapse of the period, and upon request by the Supplier, the AMLC shall release the warranty security, provided, that the goods supplied are free from patent and latent defects and all conditions imposed under the Terms of Reference have been fully met.
