TERMS OF REFERENCE

GAD Training on Empowered Mindset
(Purchase Request No. 25-003)

BRIEF DESCRIPTION

The AMLC Secretariat, through its Gender and Development Focal Point System (GFPS), will undertake the procurement of the *GAD Training on Empowered Mindset* on 27 March 2025.

The Approved Budget for the Contract (ABC) is ONE HUNDRED FORTY-TWO THOUSAND TWO HUNDRED PESOS (PHP 142,200.00), inclusive of all costs, charges and applicable taxes.

INSTRUCTIONS TO SUPPLIERS

Form of Quotation:

Suppliers¹ are required to submit its Quotation using the Prescribed Form (See Page 5-7) by the Anti-Money Laundering Council (AMLC).

Documentary Requirements:

GENERAL CONDITIONS

Quotation Price:

Supplier's quotation shall be inclusive of all costs, applicable tax, charges and other incidental expenses, including, but not limited to notarial expenses.

Quotation Validity Period:

Quotations shall be valid for 15 days from receipt by the BAC Secretariat.

Liquidated Damages:

- A delay by the Supplier in the full delivery of the services shall render the Supplier liable for liquidated damages, which shall be deducted by the AMLC from each payment or total contract price in case of one-time payment.
- Liquidated damages shall be equal to one-tenth (1/10) of one percent (1%) of the total contract price for every day of delay.

Payment:

- Payments shall be made only upon the issuance of the **Inspection and Acceptance Report (IAR)**² by the IAC.
- No payment shall be made for supplies and materials not yet delivered or services not yet rendered.
- The Supplier's request for payment shall be made in writing, accompanied by an invoice describing, as appropriate, the goods delivered and/or services performed, and by documents submitted pursuant, and upon fulfillment of other obligations stipulated in these Terms of Reference.
- Payments shall be made promptly by the AMLC within thirty (30) days from issuance of the IAR by the IAC.
- The currency in which payment is to be made shall be in Philippine Pesos.

Warranty:

- [For services] The Supplier warrants it has, and, at all time during the term of the service, will maintain the requisite personnel, competence, skill and resources necessary to provide the required services under these Terms of Reference. The Supplier also warrants that the services shall be performed in a workmanlike manner and in compliance with all applicable laws and regulations. The Supplier further warrants the availability of service, service parts and maintenance services, including repair services and preventative maintenance, during the term of the service.
