## Description

ONE (1) LOT MULTI-YEAR SUPPLY, DELIVERY, SETUP, INSTALLATION, DATA INGESTION, TESTING, AND IMPLEMENTATION OF SOFTWARE FOR ARTIFICIAL INTELLIGENCE, INCLUSIVE OF ONE (1) YEAR SUPPORT AND TRAINING

- 1. The Anti-Money Laundering Council (AMLC), through the 2021 General Appropriations Act Capital Outlay Fund intends to apply the sum of Php 52,800,000.00 being the ABC to payments under the contract for Software for Artificial Intelligence / Purchase Request No. 21-095. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The AMLC now invites bids for the above Procurement Project. Delivery of the Goods is required within four-hundred twenty (420) calendar days after receipt of Notice to Proceed subject to the delivery schedule under "Section VI Schedule of Requirements" of this Bidding Documents. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 20 December 2021, 10:30 AM. Late bids shall not be accepted.
- a.
