Based on existing network layout, AMLC have various internal VLANs, 2 ISPs, a leased line connection, and external links to government networks. AMLC is planning to add VLANs for segregation of inside network, an extra ISP, link to on-premise central management device (included in project lot), maximize GE connection of devices, connection of other network and security equipment, as well as provision for future projects.
